

OCLC FOR SPECIAL LIBRARIES

The Associate User is a new category developed by SOLINET to meet the needs of the smaller libraries who wish to use OCLC services. These services include custom catalog cards, materials location, and an ILL sub-system among others.

The Assoicate User is not a member of SOLINET and does not participate in its governance, but can access any OCLC services, and must perform its cataloging on the OCLC system. It can use any available SOLINET services, but only by paying non-member charges.

CRITERIA FOR ASSOCIATE USER STATUS

- 1. Library not current member of SOLINET.
- 2. Naterials aquisitions budget less than \$165,000.

CONDITIONS OF ASSOCIATE USER CATEGORY

- 1. Initial fee of \$500.
- 2. SOLINET profile time at \$25 per hour in addition to OCLC profile time at \$37 per hour.
- 3. One or two people must attend training sessions at SOLINET (Atlanta) at cost of \$100 per person for two day session.
 - 4. Annual fees of \$500.
- 5. If library orders en OCLC terminal, pays SOLINET surcharge of 4%.
 - 6. Library does not have vote at annual meeting.
- 7. If library wishes to change its status to that of full member, pays one-time fee of \$1000.

By paying a \$200 yearly fee, and poviding a guarantee of 48 hours of use yearly, associate users are entitled to ****** an \$8 per hour discount on Dislog base connect time. If no guarantee is provided, the discount is \$3 per hour. For BRS the discount is \$16 with a guarantee of 36 hours per year and \$25 per hour with no guarantee. Note that BRS royalty fees are not subject to discount.

what is OCLC?? OCLC (Online Computer Library Center) has been around since 1967 and is located in Dublin, Ohio. OCLC has designed and operates a bibliographic computer and telecommunications system that supports resource sharing among libraries.

Through the OCLC Online System, libraries CATALOG books, serials, and other library materials; order CUSTOM-PRINTED CATALOG CARDS; CREATE MACHINE-READABLE DATA FILES; maintain location information on library materials; facilitate INTERLIBRARY LENDING; and place and control ACQUISITIONS orders. The system can also provide bibliographic and LOCATION INFORMATION to participating libraries. Michelle's handout (following page) has more details.

Using the MAP command can be easy. The format is quickly learned: just MAPfn (TEMP) S(et) #. That 'fn' is field name. The Set number is the set in which the desired information appears. If Set 12 or S12 had reports that were of interest to you, enter MAPRN TEMP \$12 and the Report Numbers appearing in set 12 will be MAPped.

Now, what if it were 120 report number matches? Can you imagine reentering all those report numbers one at a time using the keyboard? What a savings in time, both yours and CPU time. As you can see, once you have them, you can then get selective on what is found.

Not all 'fn's are MAPpable. See the Tech Notes (page TM6-2) and to find out. Easier than that: try it! If the field is MAPpable, it will work.


